## **MSBN Criteria for Board-Approved Assessor:**

1. The assessor is an expert in the field, e.g. an addictionologist, a clinical psychologist, or has a minimum of a master's level in counseling, psychology or social work, and is licensed by the proper board(s) for his or her profession. A copy of the diploma and license shall be provided to the Board of Nursing and updated annually, or sooner if needed, to reflect current licensing status.
2. The assessor must have a minimum of five [5] years of experience working with individuals that are employed in the healthcare field that have issues related to substance use.
3. The assessor must possess an understanding of public policy and safety issues and understand how to function performing assessments for third-party referrals.
4. The assessor will consult with nurses regarding functioning in the field of nursing, the nursing setting, potential risks, and ethical implications of the situation in order to make Fitness for Duty recommendations, including but not limited to, recommendations/limitations on number of hours, hours of the day, field setting, prohibited areas of practice, etc.
5. The assessor must review accounts related to the allegation(s) with a Board of Nursing staff member prior to making any recommendations.
6. The assessor must broaden the sources for evaluation and receipt of collateral information such as conducting telephone interviews with employers, co-workers and family members, as deemed necessary.
7. The assessor must provide a minimum of three [3] credible references.
8. The assessor must utilize the following assessment tools, at minimum: SASSI-4, current DSM for accurate diagnosing, ASAM criteria-based recommendations for treatment, and CAGE assessment.
9. The assessor must possess and provide a certificate reflecting completion of SASSI training for Administration and Scoring and Clinical Interpretation.
10. The assessor must administer and/or refer nurse for a drug screen [minimum of 10 panel].
11. The assessor must provide a complete bio-psycho-social, DSM based diagnoses [including Rule-Out, if needed] or reason/s for lack of diagnosis, copies of all drug screen results, a copy of the SASSI-4 with results and interpretation, CAGE results, recommendations for treatment following ASAM criteria, a Fitness for Duty report, mental health treatment recommendations and a copy of the Release of Information for MSBN. All reports should be provided on the proper letterhead of the assessor and must include the date of the assessment, the date of the drug screen/s and the date the report is being provided to the Board of Nursing.
12. All assessments should be provided to the Board of Nursing within three [3] business days of the date of assessment. If the assessor is unable to meet the deadline, the assessor must contact the Board of Nursing within three [3] days of the assessment to provide the expected date for receipt and basis for such delay.
13. The assessor must complete all criteria for each assessment performed and failure to do so will result in the assessor being removed from the Board of Nursing Approved Assessor list.
